

## **WATCH AND WIN 2023 SWEEPSTAKES OFFICIAL RULES**

### **I. SPONSOR.**

## **VIII. WINNER NOTIFICATION.**

24. The potential winner will be notified by email, mail, or phone.

25. The potential winner will be required to complete, electronically sign, and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim their prize.

26. If a potential winner cannot be contacted, fails to submit the Declaration of Compliance within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits their prize.

27. 31. The Sponsor reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

32. Any attempt to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law.

33. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

## **X. RELEASE AND LIMITATIONS OF LIABILITY.**

34. - b. Unauthorized human intervention in the Sweepstakes;
- c. Mechanical, network, electronic, computer, human, printing, or typographical errors;
- d. Lost, late, incomplete, garbled, illegible, undelivered, stolen, damaged, delayed, postage-due, or misdirected mail, entries, application downloads, or text messages;
- e. Any other errors or problems in the administration with the Sweepstakes, including, without limitation, errors that may occur in the administration of the Sweepstakes, the announcement of the winner, the cancellation or postponement of the event, if applicable, the incorrect downloading of the application, the processing of entries, or any Sweepstakes-related materials;
